

## Idaho Health Facilities Authority Pooled Loan Program Draws

The Authority established a variable rate pooled loan program in October 1985. The structure allowed the Authority to issue bonds in its own name and relend the proceeds to participating health care facilities. Draws must be paid back by 2010 when the program ends.
